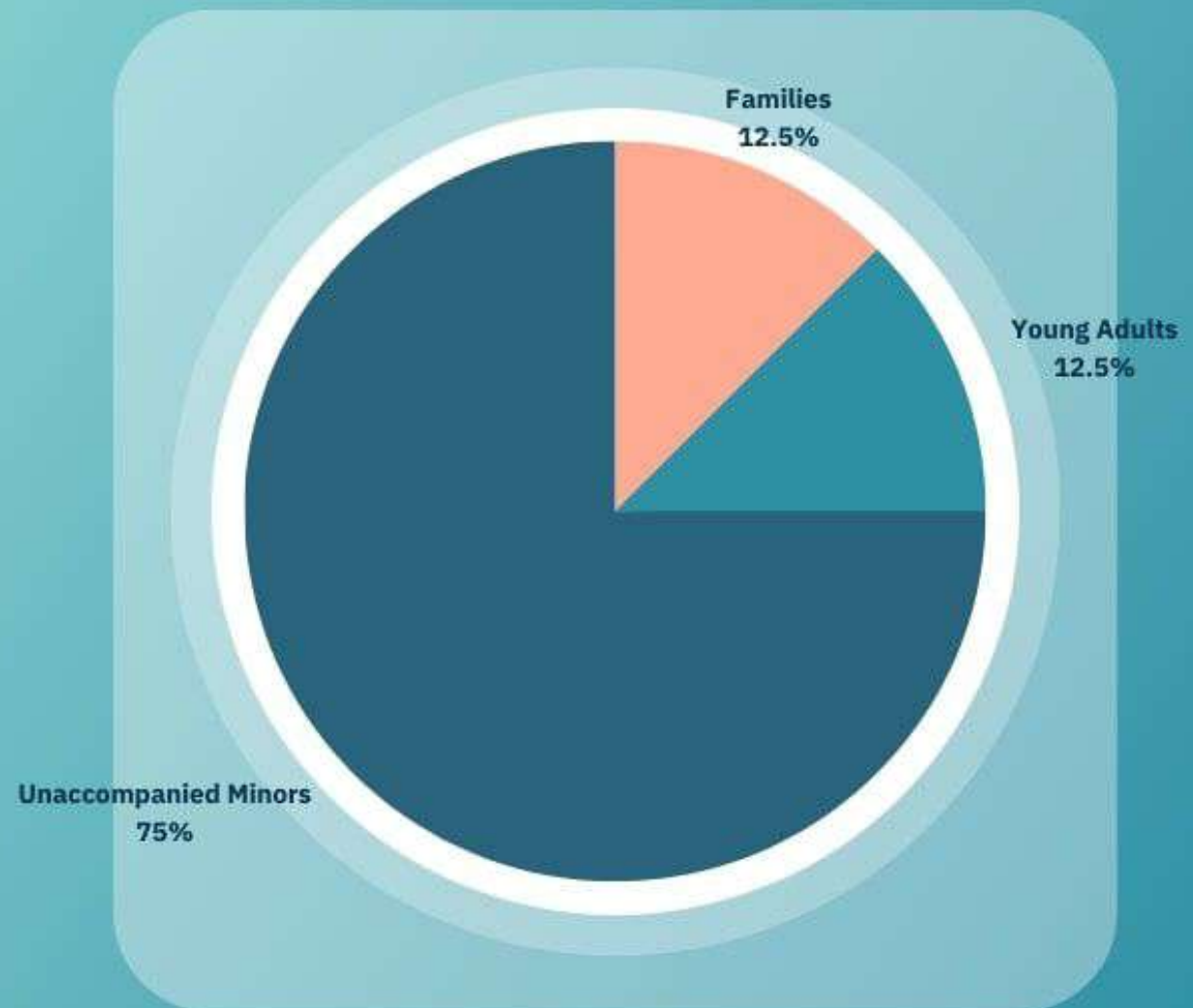

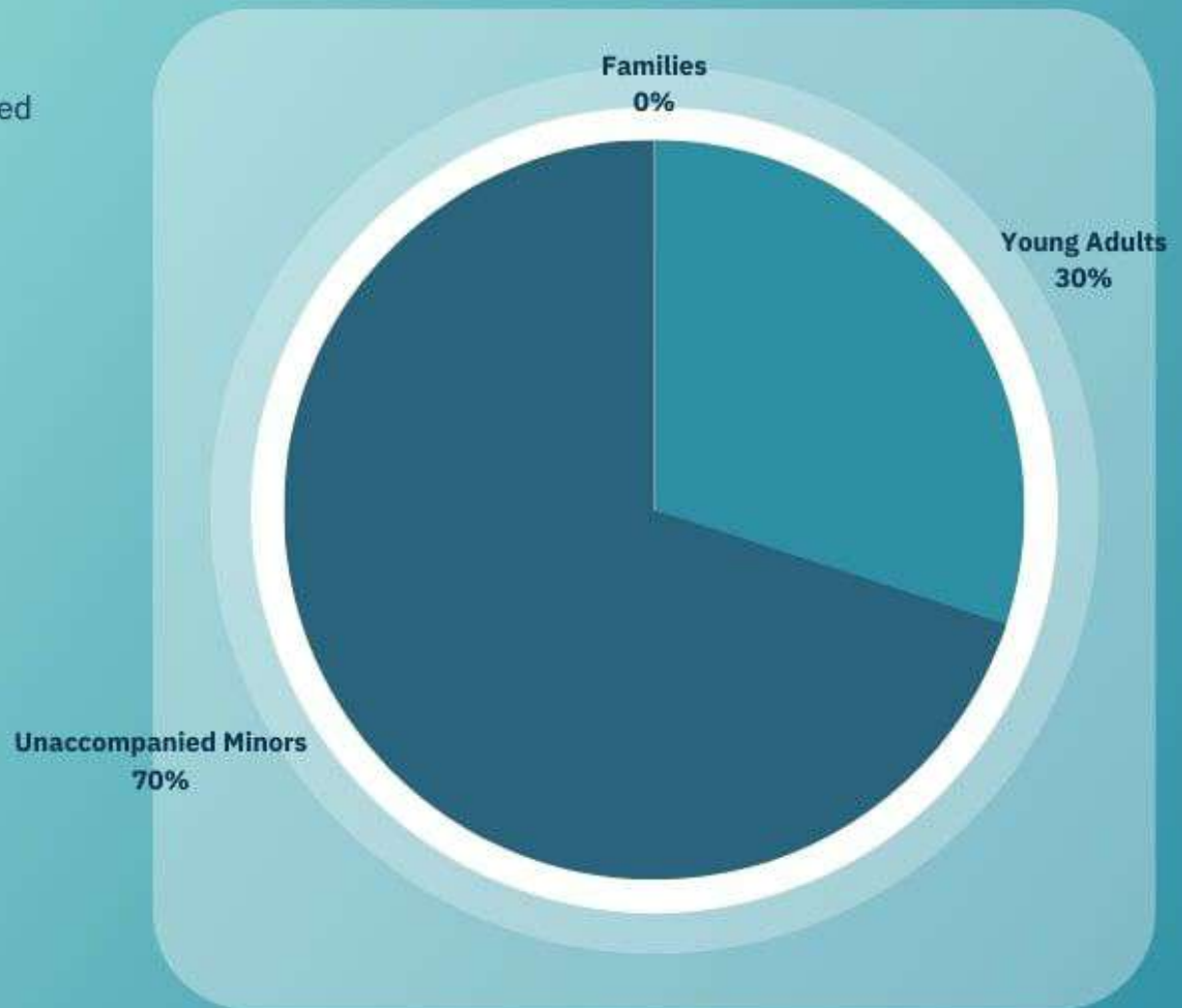

Two cases are pending decision.

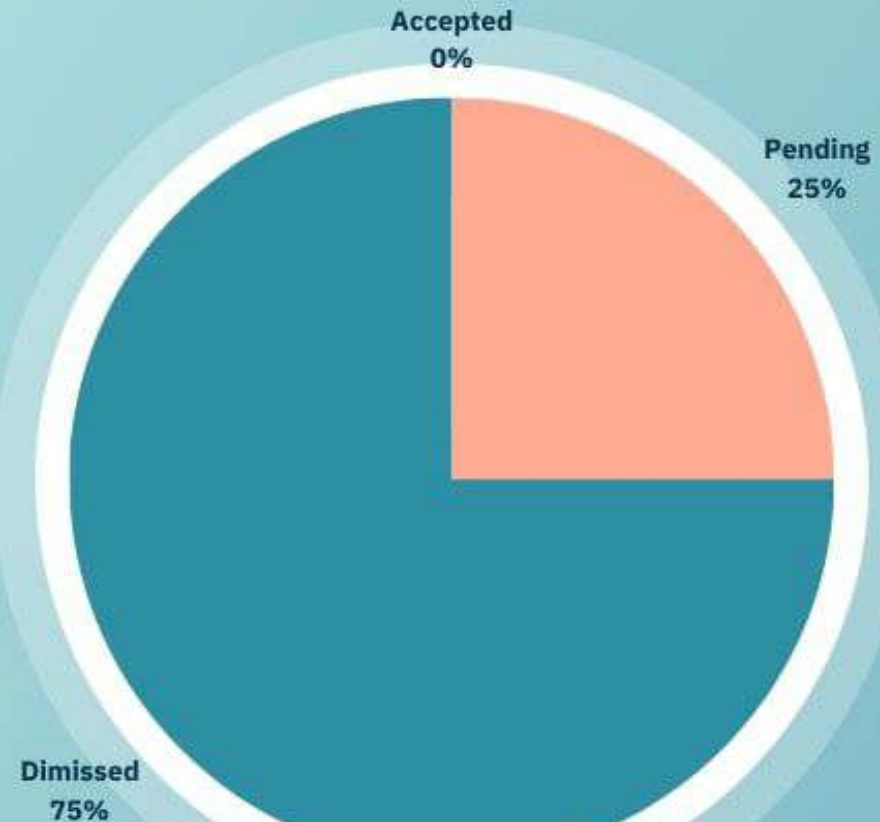

Two cases are pending decision.

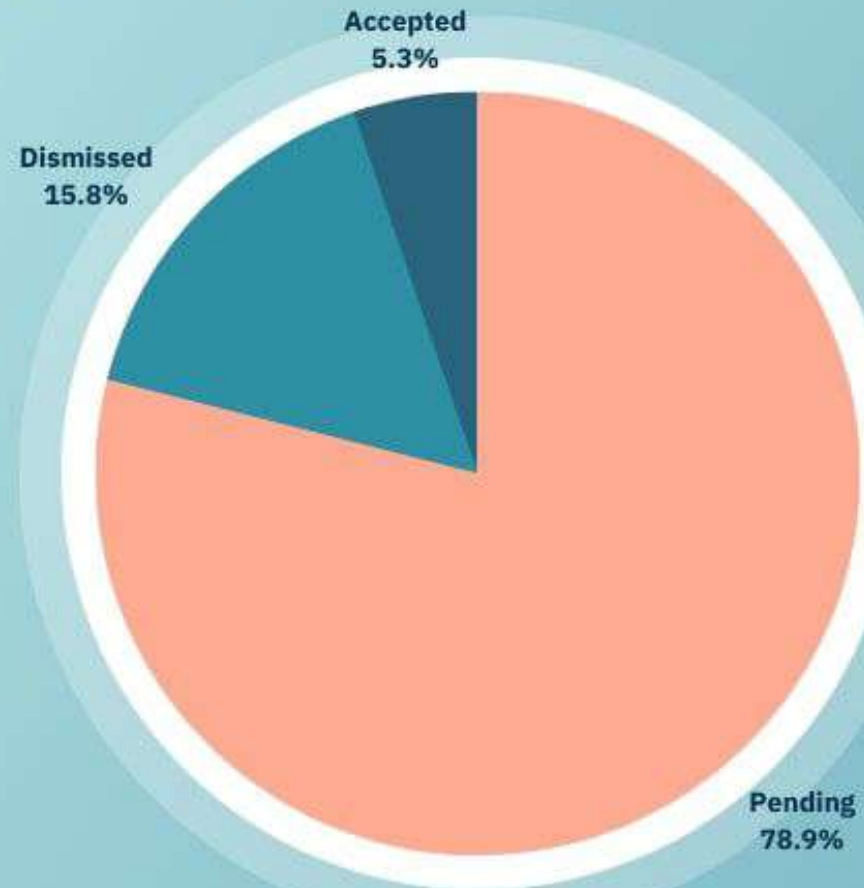

One application for annulment was granted, which concerned a young adult from Pakistan. Three cases involving young adults were dismissed. Fifteen cases are pending decision.

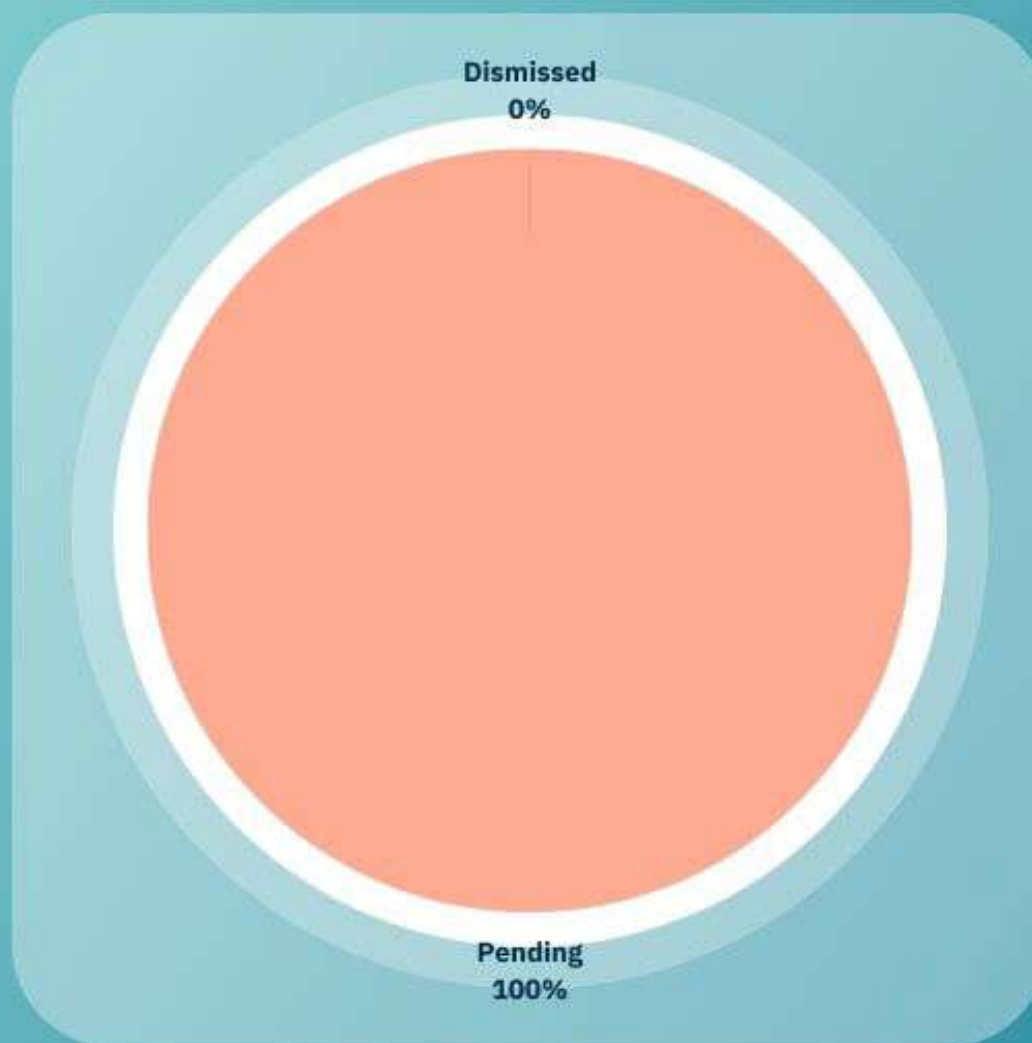

Decision on ten cases are pending.

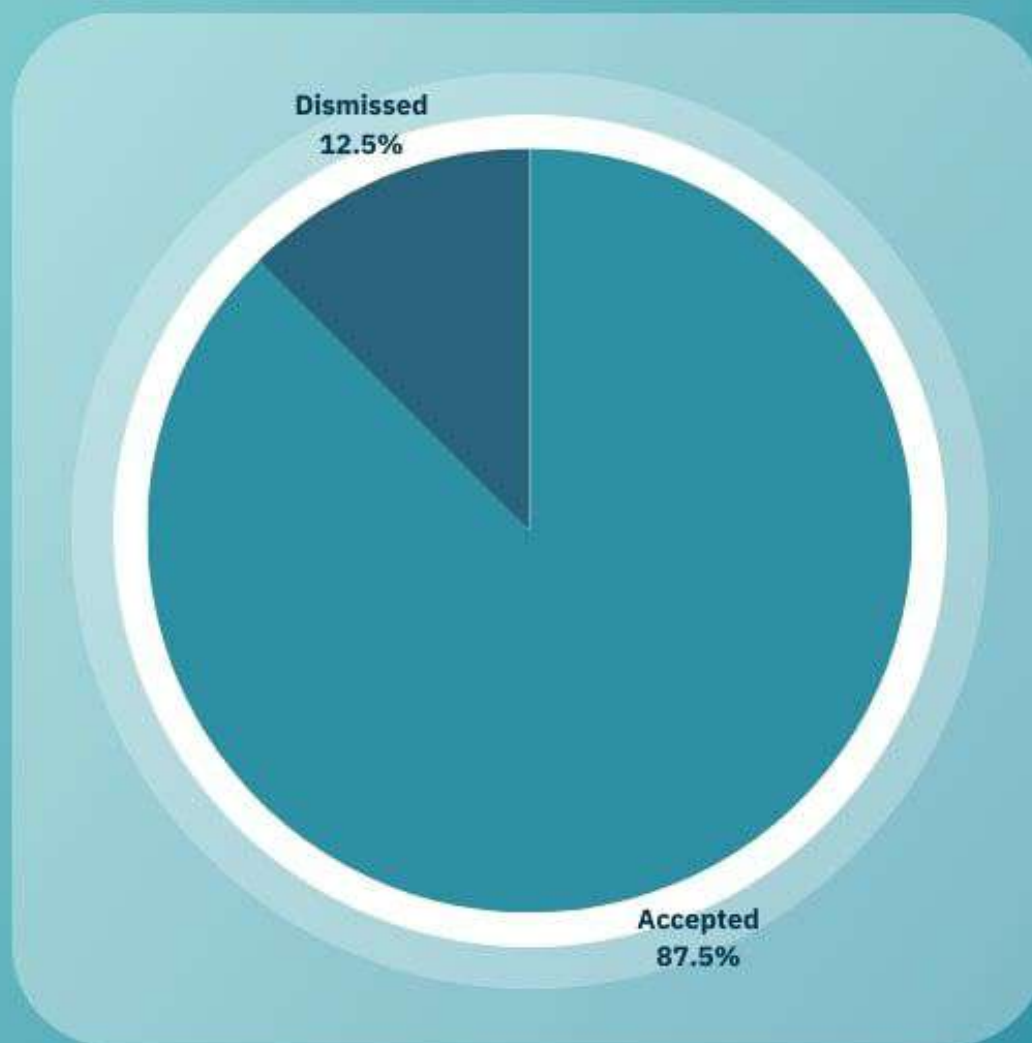


Applications for annulment of international protection decisions

■ Applications for Temporary judicial protection

Fourteen applications for temporary judicial protection were granted. Two applications concerning young adults from Pakistan were rejected

2021

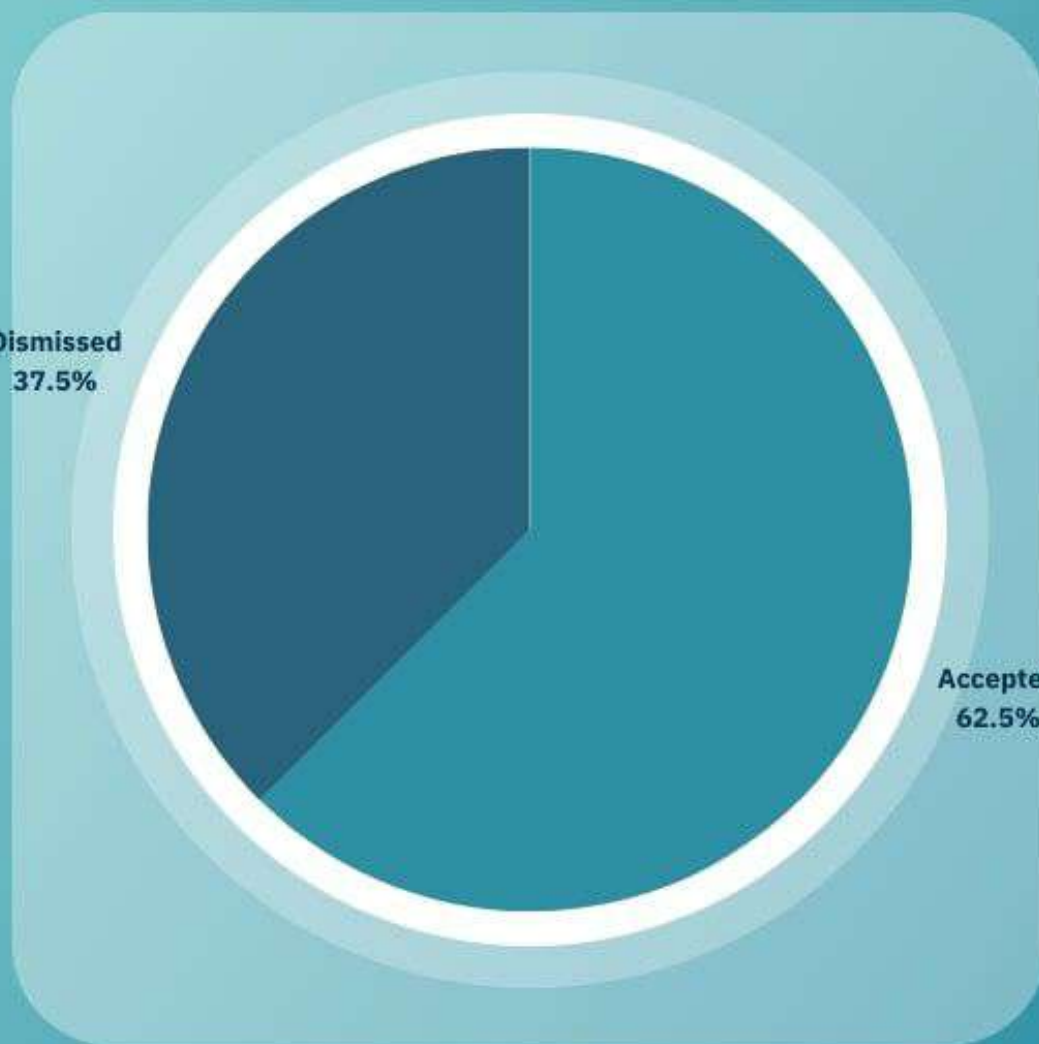
■ Applications for Temporary judicial protection

Five applications for judicial protection were granted, while three were rejected.

The rejections concerned applicants (two from Pakistan and one from Guinea) who had just become adults and were represented by legal aid.

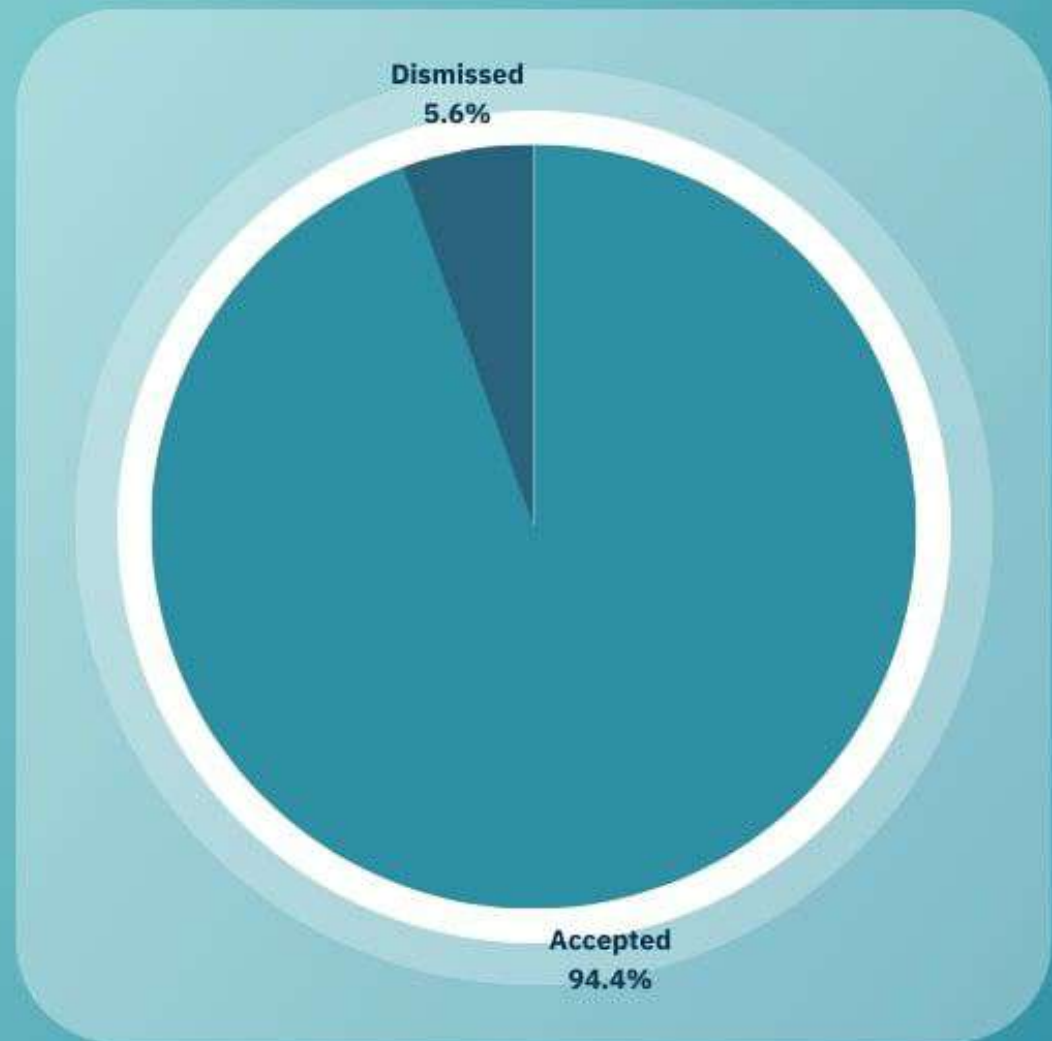


Applications for annulment of international protection decisions

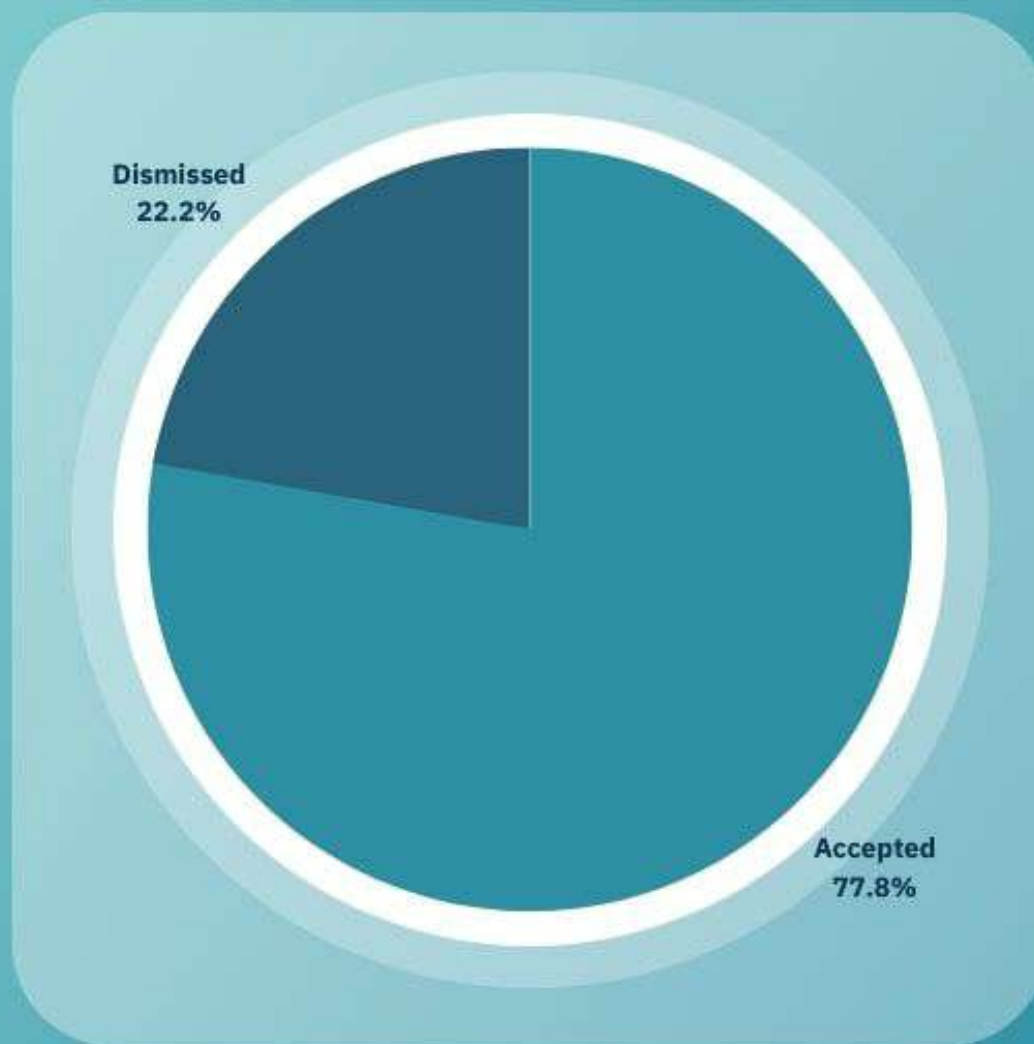

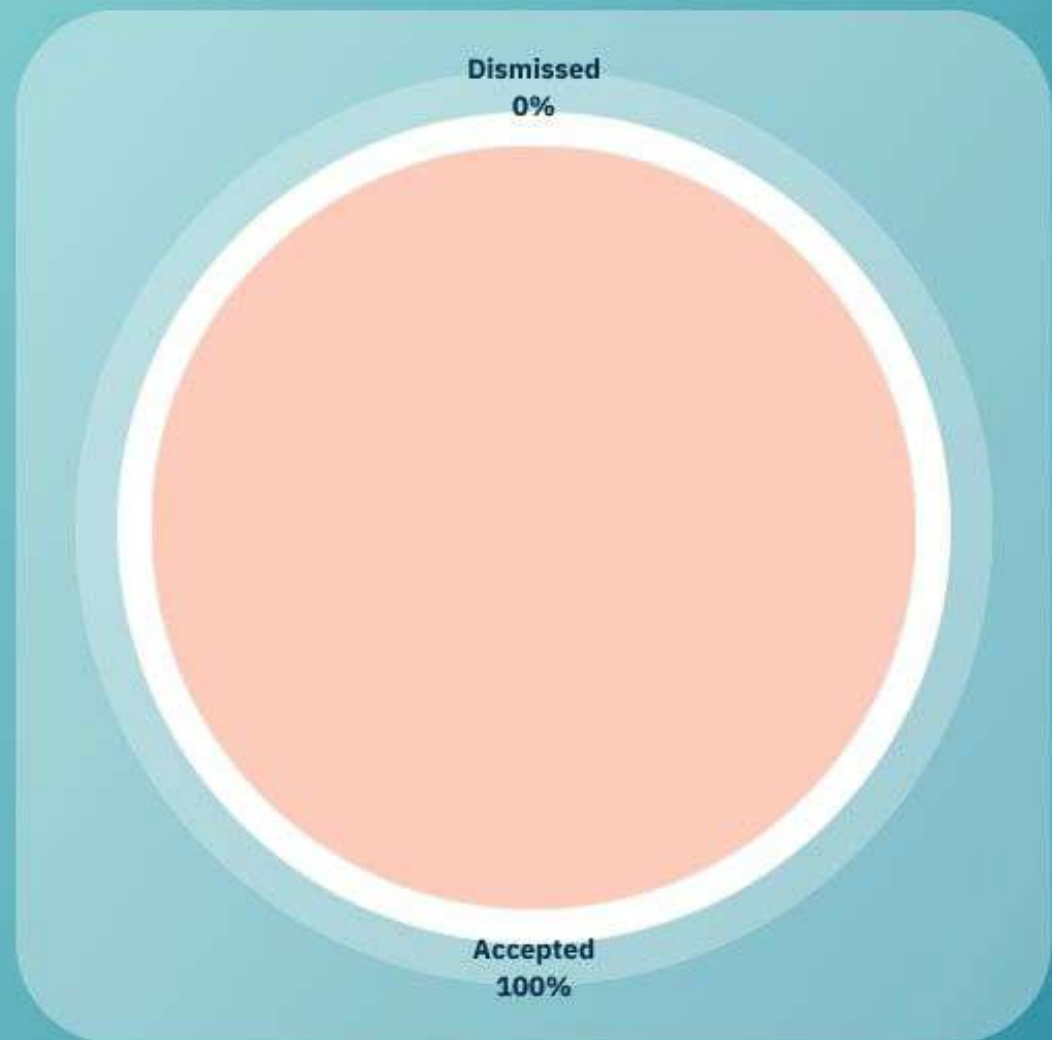

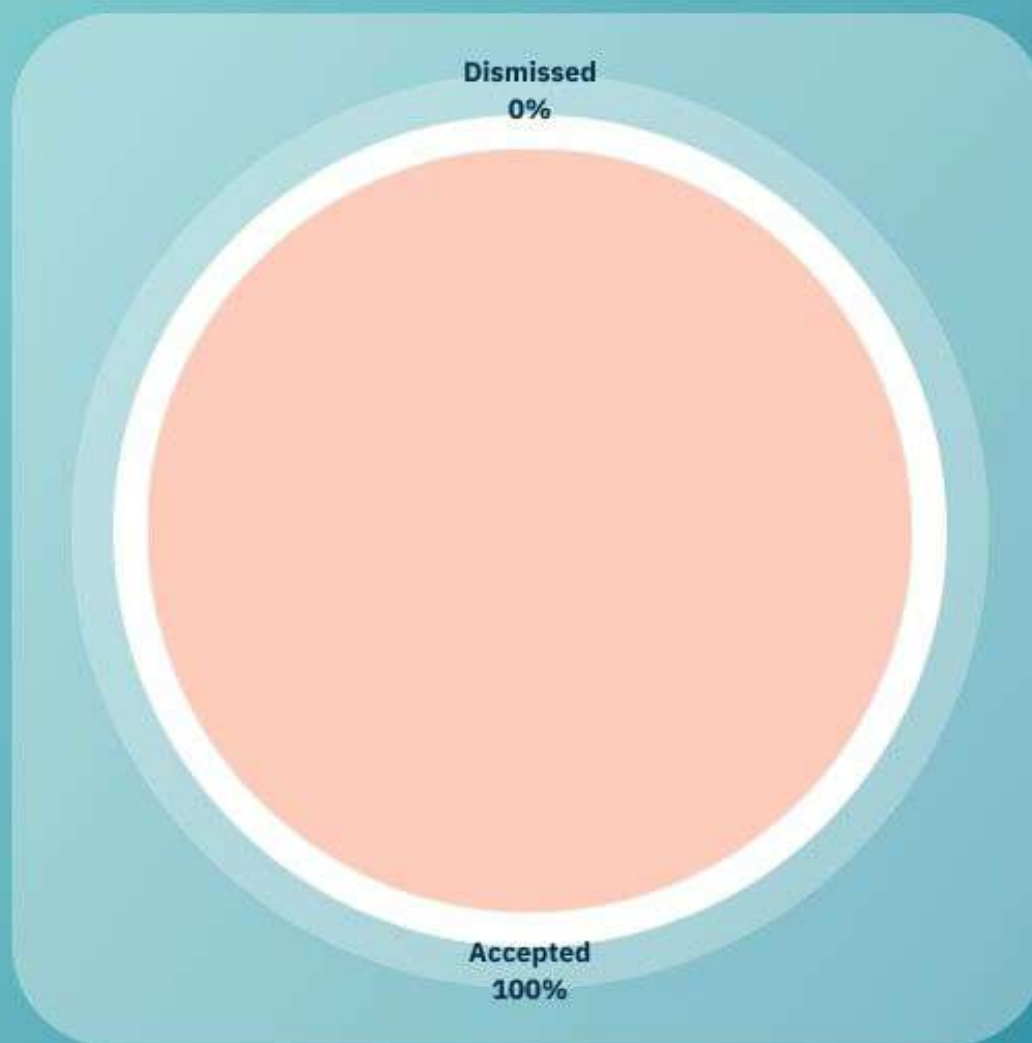
